## 4. PUBLIC HEARING

A. A Public Hearing to adopt municipal operating budget for Fiscal Year 2023-24.

Shall the City Council adopt Resolution 2023-010 adopting the fiscal year 2023-24 budget for the City of Reedsport, approving the permanent tax levy rate of \$6.1882 per \$1,000 of assessed value?

Madam Mayor opened the Public Hearing at 7:05 P.M.

#### STAFF REPORT:

Finance Director Michelle Fraley stated that at the regular Budget Committee meeting of May 22, 2023, the Reedsport City Budget Committee approved a budget totaling \$21,655,708 for Fiscal Year 2023-24. The Budget Committee approved the permanent levy rate of \$6.1882 per \$1,000 of assessed valuation as presented in the budget document.

A summary of the approved budget and a notice of the public hearing to consider the budget were published in The News Review newspaper on June 6, 2023.

A public hearing must be held in order for the City Council to consider final adoption of the budget for fiscal year 2023-24. State statute requires that a budget be adopted before June 30<sup>th</sup> of each year. Additional meetings can be scheduled if the Council wishes to consider any additional information.

Changes are allowed per ORS 294.456 with certain limitations. The following changes are allowed without republishing the budget:

- Governing body can increase expenditures of any fund up to \$5,000 or 10%, whichever is greater;
- Governing body can reduce expenditures of any fund;
- Governing body can adjust other resources.

Since the budget hearing of May 22<sup>nd</sup> new information has been obtained and the following budget amendments are being proposed.

### 5. GENERAL BUSINESS

B. Shall the City Council modify and reclassify the position description of Police Sergeant to Lieutenant and then adopt a Resolution amending Reedsport Personnel Rules and Regulations, Appendix A, Classification of Positions for Salary Ranges, assigning 2022-012 as the title?

Police Chief John Carter stated that the position of Police Sergeant for the Reedsport Police Department is both administrative and operational. The Sergeant assists the Chief in day-to-day operations of the Police Department as well as functioning in place of the Chief when the Chief is absent. In other Police Agencies the Reedsport Sergeant position would be a Lieutenant.

There are certain benefits and law enforcement associations a Lieutenant could join that are not available to a Sergeant. Reclassifying the position to a Lieutenant is also an attraction for those from other agencies who hold the rank of Sergeant to see this as a promotion. We are hopeful the reclassification will bring us a better candidate pool of trained professionals.

Approximately \$250 for a new Lieutenant Badge and Uniform Insignia.

C. Shall the City Council adopt Resolution 2023-013 establishing a mission statement for the Reedsport Municipal Jail?

Chief Carter stated that having a mission statement is a common business practice for both public and private sector service providers. It is a communication tool which will assist the level of understanding as to what is our purpose and our intent not only as a municipal organization but also internally as it relates to our organizational priorities, goals, objectives and action plans.

As a result of the Jail Assessment completed in 2019 by our insurance carrier City County Insurance Services, it was recommended that we develop and implement a Mission Statement and Goals specific to the Municipal Jail and operation thereof.

There is no fiscal impact.

D. Shall the City Council issue an intent to award and authorize the award of a construction contract for the Police/Fire Station 7 seismic rehabilitation and remodel project?

City Manager Deanna Schafer stated that ZCS Engineering & Architecture solicited bids for the seismic retrofit and remodel of the existing Police/Fire Station 7, as a public improvement project. All interested contractors attended a mandatory pre-bid meeting held on Wednesday May 3, 2023. Additionally, a copy of the project manual was made available on April 26, 2023.

Bids were due and publicly opened at Reedsport City Hall at 2:00 pm on May 24, 2023.

The apparent low bidder was DSL Builders, LLC.

On June 6, 2023 City Council has gave direction to work with the low bidder to establish a final amount through value engineering and potentially trimming portions of the project.
